

Minutes of Hastings Voluntary Action's AGM and Conference Held on Friday, 29th November 2024 – Hastings Centre

1. Welcomes and Apologies

Mary Carter as HVA Chairperson opened the meeting. The Chair accepted apologies and thanked attendees for taking time out of their busy schedules to support the AGM.

2. Approval of the Minutes of the Previous Meeting held on 17th November 2023

3. Consideration and Adoption of the Annual Report for the year to 31st March 2024

The Chair on behalf of the Trustees wished to formally thank HVA colleagues for their commitment and dedication over the past year and the huge amount of work achieved by a relatively small team.

Steve Manwaring, Director of HVA, provided the meeting with an overview of the year's work. Across the sector and across the country it has not been an easy time, HVA is no different to many voluntary organisations working in an atmosphere of challenge and volatility, with the additional challenge of withdrawal or non-availability of funds.

HVA continues to offer space at both Jackson Hall and Central Hall, undertakes independent examinations for organisations, processed c14,000 enquires, organised a wide-ranging training programme and collaborated in work on key issues affecting the communities it serves.

HVA leads and supports a wide range of major projects to name but a few – numerous men's health initiatives culminating in Hastings being one of the nationwide destinations for the Baton of Hope in 2025. LINKS continues to offer a safe meeting space and support for refugees and asylum seekers. The Making it Happen programme offering a variety of small grants to local communities. Big Local programme is coming to a close after attracting £1million for this resident-led partnership. Many age-friendly projects making Hastings a good place to grow old. Food Network and sustainable food provision enabling people access to food on a regular basis in a cost-of-living crisis. Holistic health projects focused on young people 18-24. In partnership with Oasis, Broomgrove Community Centre refurbishment, community development worker and social supermarket. Supporting MacMillan Cancer support asset-based community development techniques to tackle problem of late diagnosis for cancer.

HVA has proudly obtained the LIQA Quality Mark after complying with the rigorous application process which included providing 60 pieces of evidence and many interviews. Steve Manwaring finished by saying what a pleasure it had been to work with staff, trustees and colleagues across many organisations. Such a lot has been achieved in very challenging

The meeting raised no questions on the content of the Annual report.

Question: What is happening to the Big Local Partnership?

• Steve confirmed that the 10-year Big Local programme of resident led partnership funding had come to an end. The funding has been fully spent. Steve highlighted a new initiative in the area at Broomgrove Community Centre, work to include refurbishment of building, provision of a community worker, and a Social Supermarket.
